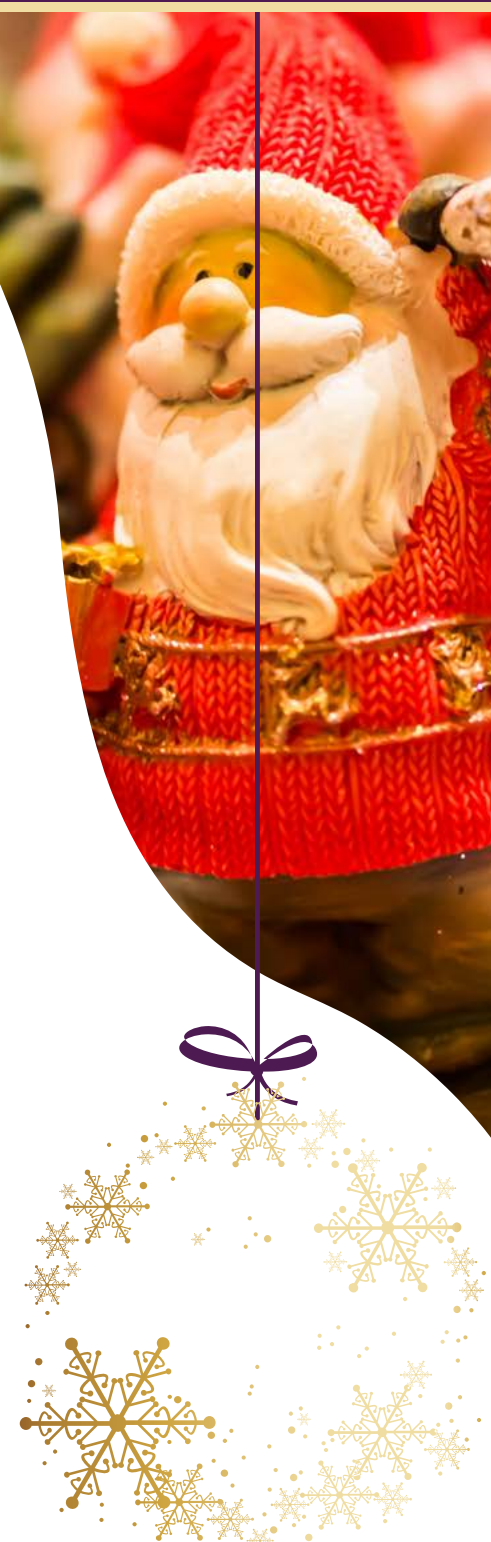

Lost, stolen or damaged Market or Pickering Casino Resort property will be charged back to the vendor.

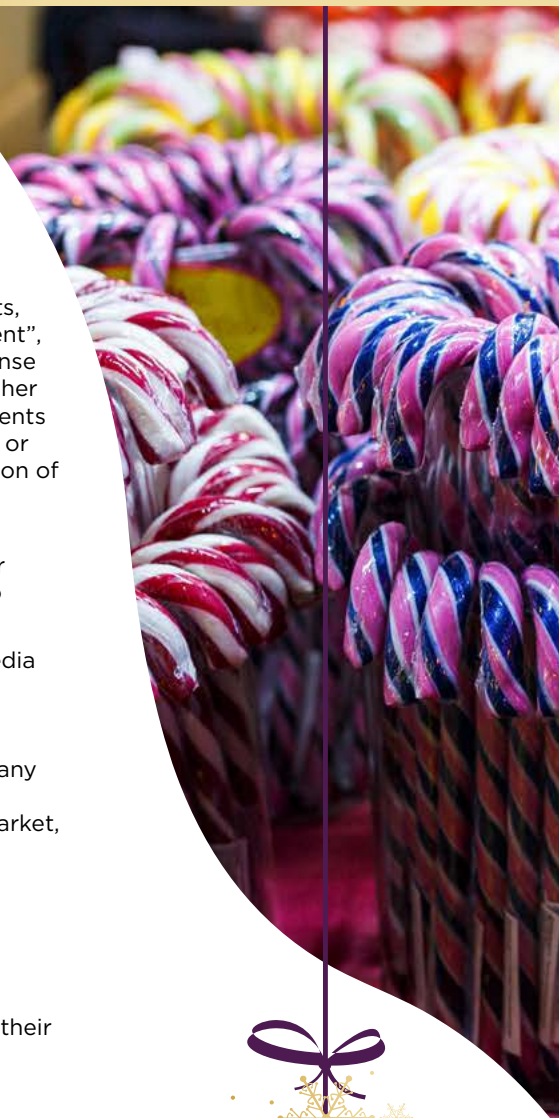
Please be advised that smoking, cannabis, e-cigarettes and vaping are not permitted.
